CHARDONNAY AND PINOT NOIR FROM CALIFORNIA, NORTHERN RHÔNE REDS AND ARGENTINEAN MALBECS shine in this week's *Wine Spectator Insider*. Sojourn places five Sonoma Pinot Noirs, most of them single-vineyard cuvées, among this week's picks, but the Chardonnays of Helen Turley's Marcassin label, reviewed by James Laube, come away peerless.

Other standouts this week include Mendoza Malbecs from the likes of Bodega Norton, tasted by James Molesworth, who also reviewed 10 Syrah-based Northern Rhône reds, including some from familiar names



like Perrin, Duclaux, Chave, Ferraton and Tardieu-Laurent.

It is, however, a buffet of outstanding and classic expressions in California Cabernet Sauvignon, Cabernet Franc, Pinot Noir and Chardonnay, from benchmark producers like Paul Hobbs and Marcassin, that take top honors among the Hot Wines, on page 4.

ARGENTINA

BODEGA NORTON

Privada Mendoza 2008

92 points | \$25 | 6,000 cases imported | Red

Rich and dense, offering beautifully detailed mocha, boysenberry, fig and black currant notes, all framed by alluring spice, anise and graphite, with a long, rich finish. A large-scaled style. Very impressive. Malbec, Merlot and Cabernet Sauvignon. Drink now through 2013.—*J.M.*

CRUZ

Malbec Mendoza Andina 2008 91 points | \$20 | 1,600 cases imported | Red

Rich, with lots of ripe, spicy blackberry, currant and boysenberry fruit layered with enticing black licorice and vibrant spice notes, followed by a winey finish. Drink now through 2012.—*J.M.*

ALTOCEDRO

Malbec Mendoza La Consulta Select 2009 90 points | \$19 | 900 cases imported | Red

Flashy toast gives this a mocha and anise jump start, backed by a core of crushed plum, blackberry and fig paste. A cocoa edge hangs on through the finish, with latent drive stretching it all out.

KSANA

Malbec Mendoza 2008 90 points | \$18 | 2,000 cases imported | Red

Very fleshy, with plum, fig and boysenberry paste flavors liberally layered with dark toast and espresso notes, followed by a broad finish. For the hedonist crowd. Drink now through 2012.—*J.M.*

BODEGA NORTON Malbec Mendoza Reserva 2008 90 points | \$20 | 61,000 cases imported | Red

Plush, with velvety blackberry, fig paste and warm currant confiture notes backed by mouthwatering ganache and espresso. A big wine, but driven and lively. Drink now through 2012.—*J.M.*

TRIVENTO

Amado Sur Mendoza 2009 90 points | \$15 | 1,000 cases imported | Red

Dark, with a core of very ripe black currant, raspberry ganache and black licorice notes, supported by polished tannins. A raspberry note emerges more on the lengthy finish. Very solid. Terrific value. Malbec, Bonarda and Syrah. Drink now through 2012.—J.M.

CALIFORNIA



MARTINELLI

Chardonnay Russian River Valley Zio Tony Ranch 2008 94 points | \$50 | 545 cases made | White

Bold, ripe and fleshy, with exotic floral and spicy notes, along with flavors of bubble gum, fig, honeydew melon and hazelnut. Full-bodied and viscous, gaining depth and nuance on the long, tapered finish. Drink now through 2017.—*J.L.*

SOJOURN

Pinot Noir Sonoma Coast Sangiacomo Vineyard 2009 94 points | \$48 | 875 cases made | Red

Impressive and notable for its polish and finesse, this smoothtextured red shows subtle cherry, berry, mineral and spice flavors that build depth and intensity, all the while maintaining an understated elegance. Drink now through 2020.-J.L.

LEVIATHAN California 2008 93 points | \$48 | 2,300 cases made | Red

Starts understated, building depth and dimension, featuring bright, rich black currant, anise, sage and black licorice character. A full-bodied orchestration of flavors at the end weave together into a tapered finish. Cabernet Sauvignon, Merlot, Syrah and Cabernet Franc. Drink now through 2022.—*J.L.*

MARCASSIN

Chardonnay Sonoma Coast Three Sisters Vineyard 2006 93 points | \$75 | 650 cases made | White

A rich, full-bodied style, showing melon, spice and green apple flavors, with a slice of citrus. Clean and alluring, building depth on the finish, where the smoke and roasted fig flavors become more prominent. Drink now through 2017.—*J.L.*

SOJOURN

Pinot Noir Russian River Valley Wohler Vineyard 2009 92 points | \$48 | 215 cases made | Red

Shows wonderful focus, vibrancy and balance, with a mix of spicy berry, mineral, anise and blackberry flavors. Pure, intense and snappy, ending with a taut, tannic finish. Best from 2012 through 2020.—*J.L.*

SOJOURN

Pinot Noir Sonoma Coast Rodgers Creek Vineyard 2009 91 points | \$48 | 575 cases made | Red

An enticing floral mix of herb, spice, black cherry and wilted rose, this builds intensity and depth, with detailed blackberry, mineral and cedar notes that firm up on the finish. Drink now through 2018.—*J.L.*

SOJOURN

Pinot Noir Russian River Valley 2009 90 points | \$42 | 325 cases made | Red

Complex, with dried berry, cherry, mineral and sage flavors that are dense, detailed, full-bodied and layered, ending with a pleasing mineral aftertaste. Drink now through 2016.-J.L.

Crozes-Hermitage Les Trois Chênes 2009 92 points | \$35 | 500 cases imported | Red

A modern style, with dark, alluring espresso and bittersweet cocoa notes leading the way, followed by muscular black currant paste, crushed fig and plum sauce notes. The long, broad, dark finish has lots of latent drive. There's plenty of stuffing here, and this should open with a touch of cellaring. Best yet from this emerging producer. Drink now through 2015.—*J.M.*

EMMANUEL DARNAUD

Crozes-Hermitage Mise en Bouche 2009 91 points | \$28 | 150 cases imported | Red

Dark and winey, with very lively acidity supporting the layered blackberry, black licorice and loganberry fruit. A tangy streak of white pepper cuts through on the finish. Delicious. Drink now through 2014.—*J.M.*

DELAS

Crozes-Hermitage Les Launes 2009 91 points | \$21 | 500 cases imported | Red

Stylish, with lots of mocha, spice and black tea aromas backed by velvety-textured blackberry and raspberry fruit. The long, suave finish stretches out nicely, with the fruit and spice hanging on. Drink now through 2014.—*J.M.*

MAISON NICOLAS PERRIN

Crozes-Hermitage 2009 91 points | \$33 | 1,000 cases made | Red

Vivid, with superracy blackberry, black cherry and fig fruit liberally laced with graphite and black tea. A latent iron note leaves a tangy, mouthwatering finish and adds length. Drink now through 2014.—*J.M.*

TARDIEU-LAURENT

Côte-Rôtie 2008 91 points | \$92 | 150 cases made | Red

Very stylish, with a mix of blueberry, blackberry and red currant fruit laced with black tea and a tangy iron note. Lilting spice hints chime in on the finish. Drink now through 2015.—*J.M.*

GEORGES VERNAY Côte-Rôtie Maison Rouge 2007

91 points | \$125 | 290 cases made | Red

Alluring, with perfumy black tea, sweet tapenade and maduro tobacco notes leading the way for a core of mulled plum and blackberry fruit. A smoky mesquite note weaves through the finish. Drink now through 2015.—*J.M.*

JEAN-LOUIS CHAVE

St.-Joseph 2008 90 points | \$60 | 200 cases imported | Red

Nicely plush for the vintage, with tangy iron and white pepper notes melded into the damson plum and black cherry fruit. There's a lingering perfume on the finish. Drink now through 2013.—*J.M.*

BENJAMIN & DAVID DUCLAUX

Côte-Rôtie La Germine 2008 90 points | \$75 | 400 cases imported | Red

Very polished, offering a long, pure, silky palate of red and black currant, iron and black tea flavors that stay focused through the lengthy finish, with nicely integrated acidity. Drink now through 2014.—*J.M.*

FERRATON PÈRE & FILS

Crozes-Hermitage La Matinière 2009 90 points | \$24 | 1,000 cases imported | Red

Very solid, with a deliciously winey core of mulled black cherry, currant, pepper, maduro tobacco and iron all rolled together and then running through the juicy finish. Drink now through 2013.—*J.M.*

ALAIN VOGE

Cornas Les Chailles 2008 90 points | \$48 | NA cases made | Red

Bright and very lively, with lots of red currant, blackberry and mesquite notes pushed by roasted vanilla, tobacco and olive. Shows good intensity on the finish, while staying focused and pure. Very solid for the vintage. Drink now through 2014.—*J.M.*

HOT WINES

MARCASSIN

Chardonnay Sonoma Coast Marcassin Vineyard 2006 96 points | \$125 | 725 cases made | White

At once bold, rich and layered, with a measure of delicacy and finesse, unfolding to tiers of fig, melon, bubble gum, spice and honeysuckle. Finishes with a dash of cedary oak. Drink now through 2017. *From California.*—*J.L.*

PAUL HOBBS

Cabernet Sauvignon St. Helena Beckstoffer Dr. Crane Vineyard 2008

<u>95 points | \$150 | 466 cases made | Red</u>

Bold, rich, intense and generous, with a perfumed, aromatic mix of ripe blackberry, currant, anise, sage and licorice. Full-bodied, gaining depth and richness on the finish, where this gains an even tighter focus. Drink now through 2020. *From California.*—*J.L.*

DELECTUS

Cabernet Franc Knights Valley 2008 94 points | \$75 | 575 cases made | Red

A profound, strikingly rich, juicy and layered wine, spilling over with blackberry, black licorice, plum sauce and roasted coffee notes. Full-bodied, with nutmeg and sage elements, ending with a long, persistent finish. Best from 2012 through 2020. *From California.*—*J.L.*

SOJOURN

Pinot Noir Sonoma Coast Ridgetop Vineyard 2009 94 points | \$59 | 250 cases made | Red

Very ripe and juicy, with lively, vivid plum, black chery and wild berry fruit that's full-bodied, picking up red and black licorice and richer berry pie flavors that build depth and intensity. Drink now through 2018. *From California.*—*J.L.*
